This is an Addendum to the original Construction Documents issued for the City of Lawrence Veteran's Memorial Stadium Synthetic Turf Replacement. Athletic Field Improvements, dated October 12, 2016. In all other respects, the terms of the original documents will remain in full effect. However, if there is a conflict between this Addendum and the original specifications, the terms of this Addendum will prevail.

## 1.0 Plan Set - Sheet L2 of 2 - Detail #3 (Football Field Layout)

- a. The synthetic turf carpet/fibers in both football end zones to be tufted NAVY BLUE with inlaid WHITE letters spelling LANCERS. See Image #1 for detail. All other requirements for either tufted, inlaid or painted sports lines, letters and logos are to be installed as per the original specifications.

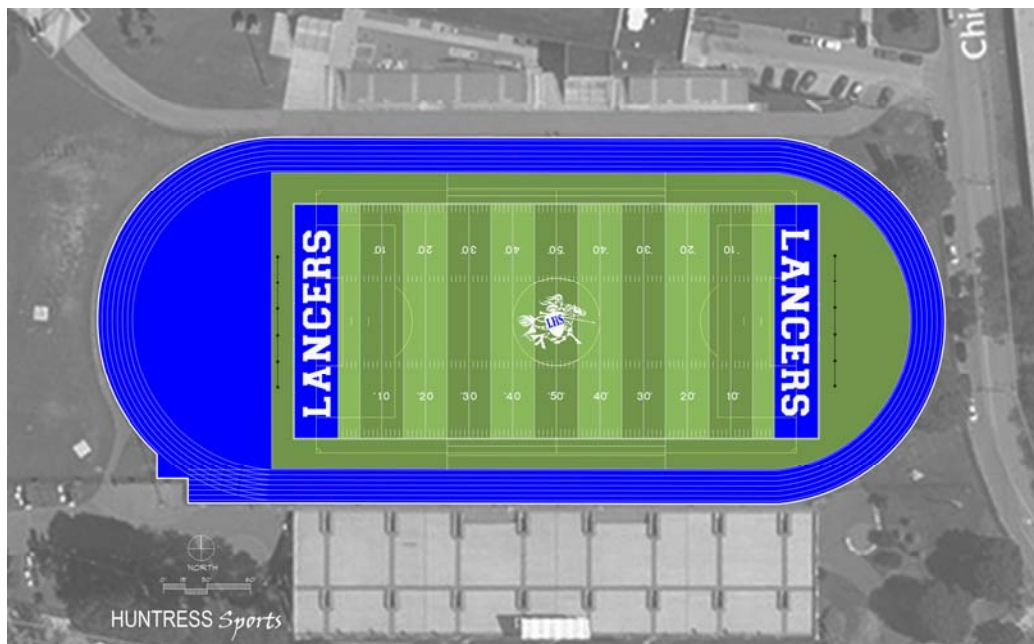

**2.0 The following are a summary of questions submitted by bidders.**

1. Is the alternating panel color every 5 yards or 10 yards?

*Answer: Alternating panel color is every ten yards, as shown in Image #1.*

2. Does the alternating panel color extend beyond the football field sideline?

*A. No, the alternating panel color stops at the limit of the football side line, as shown in Image #1.*

3. Please confirm which sports lines, lettering and logo are to be inlaid/tufted and which are to be painted.

- A. 1. The Football Field, including all numbers, lines & hash marks is to be tufted/inlaid.  
2. The Football Field end zone lettering and center logo to be inlaid.  
3. The Soccer Field, including all lines and arcs is to be tufted/inlaid.  
4. Men's & Women's Lax to be painted, owner to select color from standard colors available.  
5. Field Hockey to be painted, owner to select color from standard colors available.*

4. Are the project AutoCAD files available?

*A. The AutoCAD files will be provided to the successful bidder when a Notice to Proceed is issued. The AutoCAD files include a digitized version of the Center Logo.*

5. Is the turf manufacturer responsible to clean the existing debris on the 400m track surface?

*A. Yes, The scope of work for the synthetic turf installation shall be amended to include sweeping and cleaning by means of a gas powered leaf blower, hand sweeping and power broom, as appropriate, to remove the debris, including glass, from the resilient track surface.*
