**ALL BID PRICES MUST BE SUBMITTED ON THE ATTACHED AMDNEDED FORM FOR GENERAL BID. Bids not submitted on this sheet will be rejected.**

**I. The following items are clarifications:**

1. Items # 100.7, 100.8, 100.9, 100.61, 100.8 & 100.9 - should read "FURNISH AND INSTALL END POST FOR THE RESPECTIVE SIZE OF FENCE."  
**Answer: That is correct; the item should read "Furnish and Install End Post..."**
2. ITEMS # 100.71, 100.81, 100.91, 100.71, 100.81 & 100.91 – should read "FURNISH AND INSTALL CORNER AND INTERMEDIATE POST FOR THE RESPECTIVE SIZE OF FENCE"  
**Answer: That is correct; the item should read "Furnish and Install Corner and Intermediate Post..."**
3. ITEM # 669, 670, 671, 672, 673 & 674 ALREADY EXIST UNDER ITEM # 665, 666, 667, & 668 – Should they be removed from the bid?

Answer: No, items 665 thru 668 are intended to be for Chain Link Fence. Items 669-674 are intended to be for miscellaneous fences (wrought iron, wood, PVC, vinyl, etc.)

4. ITEM # 100.13, 100.14, and 100.15 - THE GATE ITEMS ARE BY THE FOOT, IS IT POSSIBLE TO SPECIFY WHETHER WE ARE DEALING WITH PEDESTRIAN OR VEHICULAR GATES, IT MAKES A BID DIFFERENCE PRICING WISE?

Answer: These are pedestrian gates.
