Re: Title I, IIA and III Services for Private Schools in Lawrence RFP

This Addendum modifies and forms a part of the Bid Set documents dated August 15, 2016.

This Addendum consists of the following: Two (2) type pages.

Where any items called for in the bid documents are supplemented here, the supplemental requirements shall be considered as added thereto. Where any original item is amended, voided, or superseded here, the other provisions of such items not specifically amended, voided, or superseded shall remain in effect.

I. The following items are the City's responses to Bidder questions:

- 1) **Question:** The total allocation shown in the RFP is \$239,185. Can the district provide breakdown of funding per each funding source (Title I, Title II and Title III)?
Answer: *The private schools receive an allocation from Title I and Title IIA, there is no allocation provided under Title III. ESL services are able to be provided as part of Title I services.*

Based on the overall allocation for Lawrence, the breakdown for the private schools is:

*Title I - \$233,444
Title IIA - \$ 5,742*

- 2) **Question:** Can the District provide a breakdown of funding per campus for Title I, Title IIA and Title III?
Answer: *The following are estimates for Title I based on the FY'16 allocations and participation rates:*

Lawrence Catholic Academy \$97,813

Central Catholic High School \$44,354

NOTE: 1% of each of these allocations needs to be put toward parent engagement activities.

Title IIA is allocated similarly with each school getting a percentage of the allocation based on enrollment:

Bellesini Academy \$ 459

Esperanza Academy \$ 327

Lawrence Catholic Academy \$2,406

Central Catholic High School \$1,092

Notre Dame Cristo Rey HS \$1,458

3) **Question:** If hardware and software is required for Title I & Title III, will the District provide that hardware and software?

Answer: The district does not provide hardware for Title I and III programs implemented in Private Schools. The software licenses would need to be factored into the cost for the program implementation as part of a submitted proposal.
