Re: Furnish & Install Street Name Signs IFB

This Addendum modifies and forms a part of the Bid Set documents dated June 28, 2017.

This Addendum consists of the following: two (2) typed pages.

Where any items called for in the bid documents are supplemented here, the supplemental requirements shall be considered as added thereto. Where any original item is amended, voided, or superseded here, the other provisions of such items not specifically amended, voided, or superseded shall remain in effect.

The bid due date and time remains unchanged.

I. The following items are the City's responses to Bidder questions:

- Question:** Will a full list of street names be provided at the time of contract award?
Answer: Yes
- Question:** Is the 8"(height) aluminum sign blade with 4" street name letters and 3" prefix/suffix all uppercase correct?
Answer: Yes
- Question:** Regarding Police detail requirements, will the contractor be reimbursed for costs associated with the hiring of Police details?
Answer: The Contractor will not be reimbursed for the costs associated with the hiring of Police Details.
- Question:** Regarding the Street Sign Assembly, are there 2 Street Name signs for each assembly including the sign support?
Answer: Yes, there are two signs for each assembly.

5. **Question:** Regarding the Street Sign sizes Page 12 of the specifications has the size to be 12" Wide and sheet 13 details the sign size as 8" Wide. Please clarify what size blade is to be used 8" or 12"?
Answer: Use an 8" wide measurement
6. **Question:** Regarding the Sign posts a U-Channel type post is displayed but does not show what weight post should be used 2 LB, 3 LB or 4LB; please stipulate what weight post is to be used. Regarding the Square tube type post it displays 1 -3/4", 2", the MassDOT Standard is 4 LB. per Ft. for U-Channel type and 2-1/4" for Square tube. Please clarify what size post shall be used for this bid?
Answer: For U-channel type, use 3 LB/LF weigh post. For the square type, use 1-3/4" size.
7. **Question:** It was unclear if this was a large engagement to get the signs done or if this is an as needed contract i.e. one or more at a time. Is there a definitive installation plan for this project?
Answer: Yes, this is a large project with a definitive installation plan. Street names will be given at the time of contract award.
